GENERAL SERVICE REGULATIONS

The Victory II Ferry will be made available for public service to Bradford Island and Webb Tract subject to the following conditions:

1. Ferry service is not guaranteed and is subject to the availability of captain/crew, weather and other safety issues, and mechanical failures.
2. Vehicle access on the ferry will be subject to availability of space on a first-come, first-serve basis. After-hour service may be required for unusual or high levels of traffic (e.g., equipment delivery, material transport) and should be scheduled in advance.

3. Normal hours of operation are Monday through Friday, 9:00AM to 5:00PM,
on the hour, except 12:00 noon.

Saturday Runs are 8 AM, 9 AM, 10 AM, 11 AM and 12 Noon.

Sunday Runs are 11 AM, 12 PM, 1 PM, 2 PM and 3 PM

The LAST ferry run is considered to be, the last time of the day that the ferry is outlined above.

4. Ferry service to Bradford Island will be charged as follows:

5. Ferry service to Webb Tract will be charged as follows:

(BRADFORD ISLAND LANDOWNERS)

Ticket Pricing is as follows:

Ticket Costs for one (1) Round Trip Ride \$15.50

2 axles = 2 Tickets @ \$7.75 ea. = \$15.50

3 axles = 4 Tickets @ \$7.75 ea. = \$31.00

4 axles = 6 Tickets @ \$7.75 ea. = \$46.50

5 axles = 8 tickets = @ \$7.75 ea. \$62.00

NO Refunds/Not Transferable/If ticket prices change, you will have to pay the difference in the cost of the new ticket rate. The \$15.50 ticket cost applies to automobile & motorcycles.

NEW PRICE EFFECTIVE 01/06/2023

The Tolls are TEMPORARY until Bradford Island landowners either pass a new Proposition 218 or funding from another sources is identified to fund the ferry and the operations and maintenance of Bradford Island.

WALK ONS PRICE IS \$7.75 (1) TICKET

Bike, motorized bike, skateboard, and any other type of rideable elements.

Landowner ferry hangers will NO longer be valid for free rides after 01/06/2023

Multiple Trips in ONE day will require Multiple tolls to be paid.

b. Other charges may apply for unusual traffic requirements (e.g., outside contractors, large equipment, heavy livestock).

6. After-hours service can be scheduled in advance subject to the availability of the captain/crew, see attached regulations.

After-hours service charge is \$500.00 per hour.

7. Standard ferry capacity is 9 vehicles (Depending on the size of the vehicle). Oversized vehicle limits are 16-foot width, 63-foot length, and 40-ton weight.

AFTER-HOURS SERVICE REGULATIONS

1. After-hours ferry service is defined as any morning anything prior to the first start time, evening anything after the last ferry run time of that specific day (see schedule for specific days and times) or between run service that is not included in the normal schedule of the ferry.

2. After-hours ferry service should be scheduled in advanced whenever possible and the executed

Authorization Form or facsimile posted on the ferry 24 hours in advance.

3. After-hours ferry service requires availability of captain/crew and approval of two ferry directors.

Unauthorized after-hours service is prohibited.

4. After-hours ferry service charges are as follows:

NON landowners \$500.00

DFA Directors have the authority to discount the additional fees if a situation calls for it and the amount could be discounted to \$250 per hour for residents/landowners.

ONLY with the approval of two (2) DFA ferry directors. And the costs for

Extended after-hour ferry service can be accommodated with approval of two (2) DFA ferry directors and availability of the ferry captain/crew.

6. After-hours ferry service payments should be made payable to the Delta Ferry Authority and submitted to the Delta Ferry Authority, Attention: Pamela Forbus in advance of requested service.

Under no circumstances are payments to be made to the ferry captain or other employees of the Delta Ferry Authority.

Frequent ferry users may establish a prepaid account. Advance payments are refundable if after-hours service is canceled within 24 hours of scheduled service.

7. After-hours usage will be billed in half-hour increments. Off-day usage will have a four-hour minimum.
8. After-hours service is non-proprietary. The requesting party responsible for payment of the after- hours rate will be given the highest priority for service, but other individuals may still utilize ferry service during the same period if space is available.
9. A completed authorization form should accompany all after-hours service requests.
