D.1 PROPOSITION 218: PRELIMINARY ENGINEER'S REPORT, RECLAMATION DISTRICT 2059 BRADFORD ISLAND, LEVEE AND FLOOD CONTROL FACILITIES IMPROVEMENT ASSESSMENT: DISCUSSION/POSSIBLE ACTION.

SCI has provided a preliminary engineer's report for an operations and maintenance assessment for the District. Action item includes: accepting the report, accepting the report with changes, reject the report, or postpone the acceptance of the report. Staff recommends accepting the report as-is.

D.2 RESOLUTION NO. INITIATING ASSESSMENT PROCEEDINGS, PRELIMINARILY APPROVING THE ENGINEER'S REPORT, AND PROVIDING FOR NOTICE OF HEARING, AND THE MAILING OF ASSESSMENT BALLOTS. DISCUSSION/POSSIBLE

ACTION. This Resolution approves the engineer's report and sets the assessment fee as provided in the engineer's report, provides for a public hearing, and directs the District Secretary to give notice of the public hearing and mail out ballots.

D.3 AUTHORIZE THE BOARD PRESIDENT TO VOTE ON BEHALF OF BRADFORD RECLAMATION DISTRICT 2059 ON THIS PROPOSITION 218. DISCUSSION/POSSIBLE ACTION. The District owns several parcels on Bradford Island and has the right to vote on this Proposition 218.

D.4 PARTICIPATION WITH OTHER DISTRICTS WITHIN THE SACRAMENTO-SAN JOAQUIN DELTA LEVEE DEFENSE SYSTEM. DISCUSSION/POSSIBLE ACTION. Districts and their engineers will jointly establish a network of 'basin groups' in the Delta to provide a structure for enhanced response to threats to levee integrity. Each Basin Group will be comprised of districts determined to be interdependent for protection or effective levee defense operations based on sound hydrological, geographical, geological, transportation, and organizational considerations.
